126/ The MDQ on the Agreement will be increased from 20,000 Dth/day to 90,000 Dth/day effective the first day of the month following the completion of Northern's PVR Antelope Hills receipt point (POI #79081) and the in-service date of the lateral line from PVR's Antelope Hills plant to the receipt point POI #79081 (Lateral Line); provided, however, the effective date of the MDQ increase will be no earlier than June 1, 2012 and no later than September 1, 2012, regardless of the status of the completion of the Lateral Line (MDQ Effective Date). If the Lateral Line is placed in-service earlier than June 1, 2012, the MDQ Effective Date shall be June 1, 2012. If the Lateral Line has not been placed in-service by September 1, 2012, the MDQ Effective Date shall be September 1, 2012.

For the period 1/1/2012 through 10/31/2014, the rate provisions are amended as follows:

- a. For the period 01/01/2012 until the MDQ Effective Date, for the contract MDQ (20,000 Dth/day), Shipper shall pay a total monthly reservation rate equal to 0.2401/Dth/day multiplied by the contract MDQ multiplied by 30.4.
- b. If the MDQ Effective Date is 06/01/2012, for the contract MDQ (90,000 Dth/day), Shipper shall pay a total monthly reservation rate equal to 0.2254/Dth/day multiplied by the contract MDQ multiplied by 30.4 for the period 06/01/2012 through 12/31/2012.
- c. If the MDQ Effective Date is 07/01/2012, for the contract MDQ (90,000 Dth/day), Shipper shall pay a total monthly reservation rate equal to 0.2307/Dth/day multiplied by the contract MDQ multiplied by 30.4 for the period 07/01/2012 through 12/31/2012.
- d. If the MDQ Effective Date is 08/01/2012, for the contract MDQ (90,000 Dth/day), Shipper shall pay a total monthly reservation rate equal to 0.2382/Dth/day multiplied by the contract MDQ multiplied by 30.4 for the period 08/01/2012 through 12/31/2012.
- e. If the MDQ Effective Date is 09/01/2012, for the contract MDQ (90,000 Dth/day), Shipper shall pay a total monthly reservation rate equal to \$0.2494/Dth/day multiplied by the contract MDQ multiplied by 30.4 for the period 09/01/2012 through 12/31/2012.
- f. For the period 01/01/2013 through 12/31/2013, for the contract MDQ (90,000 Dth/day), Shipper shall pay a total monthly reservation rate equal to 0.2401/Dth/day multiplied by the contract MDQ multiplied by 30.4.
- g. For the period 01/01/2014 through 10/31/2014, for the contract MDQ (90,000 Dth/day), Shipper shall pay a total monthly reservation rate equal 0.2233/Dth/day multiplied by the contract MDQ multiplied by 30.4.
- h. In addition to the above rates, Shipper shall pay a commodity rate equal to the maximum rate provided in Northern's FERC Gas Tariff. These rates include the applicable Annual Charge Adjustment and electric compression charges.
- i. In addition to the above rates, Shipper shall provide any applicable fuel use and unaccounted for.

In addition to the above rates, Shipper shall pay all FERC-approved surcharges that are made effective after the effective date of this Amendment and applicable to the service provided hereunder.
