

- 1/ Unless otherwise noted, negotiated Service Agreements do not deviate in any material respect from the applicable form of service agreement set forth in Northern's FERC Gas Tariff.
- 3/ The rate stated in the Negotiated Rate column is exclusive of all surcharges.
- 5/ For the period 02/01/2014 until 01/31/2019, Shipper shall pay a base reservation rate equal to maximum rates provided in Northern's FERC Gas Tariff, as revised from time to time, plus \$0.02/Dth/day.

In addition, Shipper shall (i) pay a commodity rate equal to the maximum commodity rate provided in Northern's FERC Gas Tariff as revised from time to time, (ii) provide any applicable fuel use and unaccounted for, and (iii) pay all FERC-approved surcharges applicable to the service provided hereunder.

- 6/ The following rates are applicable for the period 02/17/2011 until 10/31/2014: for 4,175 Dth/day of entitlement, Shipper shall pay a base reservation rate equal to \$0.3393/Dth/day. This rate includes all current and future reservation surcharges.

For 4,225 Dth/day of entitlement, Shipper shall pay a base reservation rate equal to \$0.2550/Dth/day. In addition, Shipper shall pay all FERC-approved reservation surcharges that are made effective after 02/16/2005 and applicable to the 4,225 Dth/day.

The reservation rates above are applicable to (i) deliveries to the Iowa Falls Ethanol delivery point from either the NBPL/NNG Ventura (Ventura) or Ogden Def. Delivery receipt points or (ii) deliveries to the Ogden Def. Delivery point from the Ventura receipt point. If Shipper uses any other receipt or delivery points on either a primary or alternate basis, the higher of the maximum reservation rate or (A) the reservation rate in subparagraph a. (\$0.3393/Dth/day) will apply to the first 4,175 Dth/day used at an alternate point(s) and the higher of the maximum reservation rate or (B) the reservation rate in subparagraph b. (\$0.2550/Dth/day) will apply on any quantities used above 4,175 Dth/day. In such event, the highest applicable rate at the highest quantity will be applied for the entire month any alternate point(s) is used.

In addition to the above reservation rates, Shipper shall (i) pay a commodity rate equal to the maximum commodity rate provided in Northern's FERC Gas Tariff as revised from time to time (this rate include the applicable Annual Charge Adjustment and electric compression charges), (ii) provide any applicable fuel use and unaccounted for, and (iii) pay the FERC-approved Carlton surcharge and all FERC-approved commodity surcharges that are made effective after 02/16/2005 and applicable to the service provided hereunder.
