126/ For the period 06/01/2012 through 5/31/2015, the rate provisions are amended as follows:

For the period 06/01/2012 through 12/31/2012, for the contract MDQ (90,000 Dth/day), Shipper shall pay a total monthly reservation rate equal to 0.3540/Dth/day multiplied by the contract MDQ multiplied by 30.4.

For the period 01/01/2013 through 12/31/2013, for the contract MDQ (90,000 Dth/day), Shipper shall pay a total monthly reservation rate equal to 0.3687/Dth/day multiplied by the contract MDQ multiplied by 30.4.

For the period 01/01/2014 through 10/31/2014, for the contract MDQ (90,000 Dth/day), Shipper shall pay a total monthly reservation rate equal 0.3519/Dth/day multiplied by the contract MDQ multiplied by 30.4.

If Shipper does not exercise its option below, for the period that begins 11/01/2014 and ends 05/31/2015, Shipper shall pay a total monthly reservation rate equal to \$0.1286/Dth/day multiplied by the contract MDQ (90,000 Dth/day) multiplied by 30.4. The rates set forth in this paragraph are applicable to any receipts of natural gas from the PVR Antelope Hills receipt point for delivery to the Antelope Hills pooling point. Shipper agrees that if any other receipt or delivery points are used either on a primary or alternate basis, the rates set forth above will not be applicable and Shipper shall pay Northern's maximum rates plus \$0.1286/Dth/day for the entire contract MDQ during any month that any other points are used.

In addition to the above rates, Shipper shall pay a commodity rate equal to the maximum rate provided in Northern's FERC Gas Tariff. These rates include the applicable Annual Charge Adjustment and electric compression charges.

In addition to the above rates, Shipper shall provide any applicable fuel use and unaccounted for.

In addition to the above rates, Shipper shall pay all FERC-approved surcharges that are made effective after the effective date of this Amendment and applicable to the service provided hereunder.

Shipper shall have a one-time option upon written notice to Northern by 03/31/2014 to not realign the entitlement from Demarc to the Antelope Hills pooling point as provided in the Agreement (i.e., to retain the Demarc delivery point beyond 10/31/2014) and to extend the term of the Agreement through 10/31/2015. If Shipper exercises its option: (i) for the period that begins 11/01/2014 and ends 05/31/2015, Shipper shall pay a total monthly reservation rate equal to the annual average maximum reservation rate/Dth/day plus \$0.1286 times the contract MDQ (90,000 Dth/day) times 30.4 and (ii) for the period that begins 06/01/2015 through 10/31/2015, Shipper shall pay a total monthly reservation rate equal to the annual average maximum reservation rate per Dth/day times the contract MDQ (90,000 Dth/day) times 30.4.
