

152/ For the period 04/01/2014 through 03/31/2015, for the Field Area, the total daily rate for the Field Area Contract MDQ shall be equal to the arithmetic value obtained from the formula $[(X) \text{ minus } (Y \text{ divided by } A) \text{ times } (B)]$ (rate) where (X) = the Midpoint price from "Gas Daily" Northern, demarc; (Y) = the Midpoint price from "Gas Daily" ANR, Okla plus \$0.07; (A) = 0.9733; (B) = 0.85. However, in no event will the daily rate be less than \$0.00. The monthly rate will be the sum of all daily rates from the formula above.

For the period 04/01/2014 through 03/31/2015, for the Market Area, the total daily rate for the Market Area Contract MDQ shall be equal to \$0.01/Dth plus the arithmetic value obtained from the formula $[(X) \text{ minus } (Y \text{ divided by } A) \text{ times } (B)]$ (rate) where (X) = the Midpoint price from "Gas Daily" Chicago city-gates; (Y) = the Midpoint price from "Gas Daily" Northern, demarc; (A) = 0.9894; (B) = 0.75. However, in no event will the daily rate be less than \$0.01. The monthly rate will be the sum of all daily rates from the formula above.

In addition to the above rates, Shipper shall provide any applicable fuel use and unaccounted for.

For the period 07/01/2014 through 07/31/2014, the rates set forth above are applicable to the receipt and delivery points (POI) listed below. Except for any volumes received from the Cheyenne Plains (POI 78441) receipt point for delivery to the NNG Field/Mkt Demaracation-16B (POI 37654) point that will be charged a total daily rate equal to the arithmetic value obtained from the formula $[(X) \text{ minus } (Y \text{ divided by } A) \text{ times } (B)]$ (rate) where (X) = the Midpoint price from "Gas Daily" Northern, demarc; (Y) = the Midpoint price from "Gas Daily" NGPL, Midcontinent plus \$0.02; (A) = 0.9861; (B) = 0.85; however, in no event will the daily rate be less than \$0.00, Shipper agrees that if any receipt or delivery points not listed below are used either on a primary or alternate basis, the rates set forth herein will not be applicable and Shipper shall pay the higher of the formula rates set forth above or Northern's maximum tariff rates each day for the entire contract MDQ for the month that any points not listed below are used.

Primary Receipt Points - ANR/NNG Greensburg (POI 179) and NNG Field/Mkt Demaracation-16B (POI 37654); Primary Delivery Points - ANR/NNG Janesville (POI 180) and NNG Field/Mkt Demaracation-16B (POI 37654); Alternate Receipt Points - Demarc Def. - Delivery (62389) and Cheyenne Plains (POI 78441); Alternate Delivery Points - Nicor-East Dubuque (POI 234)

For the period 08/01/2014 through 03/31/2015, the rates set forth above are applicable to the receipt and delivery points (POI) listed. Shipper agrees that if any receipt or delivery points not listed are used either on a primary or alternate basis, the rates set forth above will not be applicable and Shipper shall pay the higher of the rates set forth above or Northern's maximum tariff rates each day for the entire contract MDQ for the month that any points not listed are used.

In addition to the above rates, Shipper shall pay all FERC-approved surcharges that are made effective after the effective date of this Amendment and applicable to the service provided hereunder.

The Field Area firm maximum daily quantity for the summer (April through October) is 25,268 Dth/day. The Market Area firm maximum daily quantity for the summer (April through October) is 25,000 Dth/day and the winter (November through March) is 5,971 Dth/day.

153/ For the period 04/01/2014 through 10/31/2014, the total daily rate for the Contract MDQ shall be equal to the arithmetic value obtained from the formula $[(X) \text{ minus } (Y \text{ divided by } A) \text{ times } (B)]$ (rate) where (X) = the Midpoint price from "Gas Daily" Chicago city-gates; (Y) = the Midpoint price from "Gas Daily" Northern, demarc; (A) = 0.9894; (B) = 0.80. However, in no event will the daily rate be less than \$0.00. The monthly rate will be the sum of all daily rates from the formula above.

In addition to the above rates, Shipper shall provide any applicable fuel use and unaccounted for.

The rates set forth above are applicable to the receipt and delivery points (POI) listed. Shipper agrees that if any receipt or delivery points not listed are used either on a primary or alternate basis, the rates set forth above will not be applicable and Shipper shall pay the higher of the rates set forth above or Northern's maximum tariff rates each day for the entire contract MDQ for the month that any points not listed are used.
